### ***Sign-In Sheet & Acknowledgment of Participant Responsibility, Express Assumption of Risk, and Release of Liability***

I understand that during my participation in this San Diego Canyonlands, Inc. event, I may be exposed to a variety of hazards and risks, foreseen or unforeseen, which are inherent in outdoor settings and cannot be eliminated without destroying the unique character of the event. These inherent risks include, but are not limited to, the dangers of serious personal injury and property damage, and possible fatality (“Injuries and Damages”) from exposure to the hazards of an outdoor setting and San Diego Canyonlands, Inc. has not tried to contradict or minimize my understanding of these risks. I know that Injuries and Damages can occur by natural causes or the activities of other persons, or animals, either as a result of negligence or because of other reasons. I understand that risks of such Injuries and Damages are involved in travel to and activities in outdoor settings and I appreciate that I may have to exercise extra care for my own person and for others around me in the face of such hazards. I further understand that at this event there may not be rescue or medical facilities or expertise necessary to deal with the Injuries and Damages to which I may be exposed.

In consideration for my acceptance as a participant on this event I confirm my understanding that:

- I have read or listened to any rules and conditions applicable to the event made available to me, and I acknowledge my participation is at the discretion of the authorized event leader.
- The event officially begins and ends at the location(s) designated by the authorized event leader. The event does not include carpooling, transportation, or transit to and from the event, and I am personally responsible for all risks associated with this travel. This does not apply to transportation expressly provided by San Diego Canyonlands, Inc. during the event.
- If I decide to leave early and not to complete the Event as planned, I assume all risks inherent in my decision to leave and waive all liability against San Diego Canyonlands, Inc. arising from that decision. Likewise, if the leader has concluded the Event, and I decide to go forward without the leader, I assume all risks inherent in my decision to go forward and waive all liability against San Diego Canyonlands, Inc. arising from that decision.
- This Agreement is intended to be as broad and inclusive as is permitted by law. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.
- To the fullest extent allowed by law, I agree to **WAIVE, DISCHARGE CLAIMS, AND RELEASE FROM LIABILITY San Diego Canyonlands, Inc.**, its officers, directors, employees, agents, volunteers and event leaders **and the event location property owner(s)**, from **any and all liability** on account of, or in any way resulting from Injuries and Damages, even if caused by **negligence** of San Diego Canyonlands, Inc. its officers, directors, employees, agents, volunteers and Event leaders, in any way connected with this Event. I further agree to **HOLD HARMLESS San Diego Canyonlands, Inc.**, its officers, directors, employees, agents, and Event leaders, and **the event location property owner(s)**, from any claims, damages, injuries or losses caused by my own negligence while a participant on the Event. I understand and intend that this assumption of risk and release is binding upon my heirs, executors, administrators and assigns, and includes any minors accompanying me on the Event.
- I have read this document in its entirety and I freely and voluntarily assume all risks of such Injuries and Damages and notwithstanding such risks, I agree to participate in the Event.
